- I. The Intellectual Property Rights Law Program has been established according to the “Guidelines for Establishing Programs for Colleges and Departments” of National Chiao Tung University (NCTU). In order to integrate the subjects of law, technology, and management, the Program provides bachelor and graduate students the opportunity to study intellectual property rights.
- II. NCTU grants certification acknowledging program completion to the students who have successfully finished at least 18 credit hours according to the “Program Course Schedule.”
- III. The Institute of Technology Law is the primary provider of the Program’s courses. Those who apply to this program after the 95th Academic Year (inclusive) must conform to the program’s implementation measures.
- IV. Credit earned through this program is non-transferable to the “Patent Engineering” program.
